

We are aiming to create a comfortable environment for all our guests and to provide good quality services and security, that is why we would like to familiarize you with things that are **not allowed** in the territory of the Beach Club:

1. showing signs of alcohol or drug intoxication while in the Club territory;
2. carrying, displaying and using any kind of weapon, explosives or toxic substances, even with a permit to carry a weapon issued by the relevant authority;
3. presence of persons under the age of 18 without an adult legal representative/accompanying person who bears full responsibility for them, their safety and damage they may cause;
4. leaving children unattended;
5. leaving the Beach Club territory for other MillCreek venues, including MillCreek Golf Club;
6. littering; unthoughtful disposal of cigarette and cigar stubs, chewing-gum;
7. loud speech, whistling, discomfiting behavior and other actions disturbing public order;
8. using a “loud sound” mode on a mobile device; listening to music without headphones;
9. riding bicycles, roller-skating, skate-boarding except where it is permitted;
10. bringing pets to the Beach Club territory without prior agreement with the Club;
11. any promotional, sales, commercial activities not agreed with the Club;
12. parking violations like:
 - parking in undesignated areas;
 - occupying more than one car-place with one car;
 - car repair and maintenance (oil change, fluids replacement, wheel change, etc.);
 - car washing and fueling;
 - use of open fire as a source of light or to warm up the engine;
 - car driving without a driver’s license;
 - storage of flammable, combustible, explosive materials and liquids, tires, non-combustible substances in combustible packaging (including inside vehicles);
13. disorderly behavior in showers:
 - hair dyeing;
 - use of any products made of glass (dishes; detergents and cosmetics in glass containers, etc.) and open-blade razors;
 - washing shoes, clothes, swimming and rescue equipment;
14. misuse of the Club furniture, equipment, appliances, etc.
15. use of pyrotechnics, fireworks, fire show, etc. without prior agreement with the Club;
16. entering premises intended only for the Club personnel. Guests entering such premises are fully responsible for malfunctions and accidents that may have occurred in the area;
17. playing cards or other gambling for money, things, and other valuables;
18. smoking tobacco (cigarettes, cigars, cigarillos, hookahs, etc.), use of ENDS, smoking mixtures, etc. outside strictly designated places;
19. public reproduction of photo- or video-filming (photo, audio, and video works) or any part thereof made on the Beach Club premises in any material form, including processing, use, distribution, publication, change for editorial or advertising purposes;
20. taking photos or videos of other people without their consent;
21. covert surveillance of either Guests or the Club activities including with special technical means (photo, video or audio recording, quadcopters, drones or other similar devices);
22. access to the Club territory of the Guests’ security personnel, including armed persons, even with a permit to carry a weapon issued by the relevant authority;
23. presence on the Club territory of the Guests’ security personnel, including armed persons, outside strictly designated places;
24. access to the Club territory of people suffering from acute viral, contagious skin, venereal and fungal infections; open wounds and any other diseases that may pose a threat to other Guests’ health.
